- 2. The consignment should be fully described by proper shipping name and packed, marked and in proper condition.
- 3. For transported by a) Air: Lithium-ion Cells/Batteries shipped state of charge can not exceed 30%. Must comply with Section 1B of PI965 accordingly; For cells, the Watt-hour rating should not be more than 20Wh; For batteries, the Watt-hour rating should not be more than 100Wh. Watt- hour rating must be marked on the outside of the battery case (marked by manufacturer) and marked for "Cargo Aircraft only". b) Ground: Section II of PI 965.
- 4. Each consignment must be accompanied with a document such as an air waybill with an indication. The telephone number for additional information for Cascade products is 1-800-227-2233.
- 5. Quantity per package shall not exceed 10kg.
- 6. Each package must be capable of withstanding a 1.2m drop test in any orientation without damage of cells or batteries contained therein.
- 7. Lithium batteries which meet the requirements of A154 could be transported by air, and the batteries supplied by Cascade meet these requirements. Lithium batteries identified by the manufacturer as being defective for safety reasons, or that have been damaged, that have the potential of producing a dangerous evolution of heat, fire or short circuit are forbidden for transport.
- 8. Cells and batteries must be protected so as to prevent short circuits.
- 9. For Lithium ion cells/batteries contained in equipment UN 3481, use Section II of PI 967, up to two spair batteries are allowed and must be equipped with an effective means of preventing accidental activation.
